Why Attend RiskControl360°'s Group Rating Safety Series?

Employers who have had a claim in the "green year" or the previous year, have to complete a **required** two hours of safety training by June 30, 2010. For the 2009 policy period, this includes any claim occurring from January 1, 2007, through December 31, 2008. BWC's requirement applies to **any** claim an employer had within the past two years, regardless of size or severity. Two hours is the minimum amount of safety training mandated. If an employer experienced more than one claim within this period, they are still only obligated to attend two hours of safety training. If an employer has multiple policy numbers, they must attend two hours of safety training per policy.
