Procedure:

Local presidents will be solicited by the NABIP Ohio past president (or nomination committee chair) for interested individuals to be considered for the position of Secretary/Treasurer of the NABIP Ohio Board. Interested parties will follow the procedure below:

- Names for consideration must be submitted in writing
- To be considered, the person must submit a resume including a photo if possible
- A maximum of two people from each local will be considered
- A candidate must have served on the NABIP Ohio board in some capacity for at least one year
- A candidate must have served on a local board for a minimum of two years
- Resumes must be received (submitted electronically) by the NABIP Ohio Past President or nominating committee chair) within 7 days of receiving an email of your nomination.
- The nominations chair will contact the interested parties if further discussion is needed

There will be no exceptions to these guidelines.

Criteria for the candidate for Secretary/Treasurer:

- Nominees will be eliminated by lack of qualifications
- Election committee will select a candidate from the qualified group by majority vote
- Representation by each of the locals must be considered when choosing a candidate, but will not be the deciding factor
- Only one nominee will be slated by the election committee
- The slate will be sent to the membership 30 days in advance of the elections
- Any member in good standing who has served on the NABIP Ohio board at one time may run from the floor the day of the election for any position except Immediate Past President. (The Annual Meeting). Nominations from the floor cannot include an existing officer to run for a higher office that challenges a higher officer who has elected to run for office

Once the process of choosing a candidate has been agreed on by the NABIP Ohio Past President or election committee chair, no exceptions will be allowed.

Voting

Voting for officers of NABIP Ohio shall be done in person only, no proxies, no exceptions. Each local will be asked 30 to 45 days prior to the annual meeting who will be their delegates for the NABIP Ohio annual meeting. They must be chosen from the list of delegates provided to the NABIP Ohio office prior to the September board meeting and that are listed on the NABIP Ohio roster. NO EXCEPTIONS.
